- Question Chris Albeck: How many different criteria do we (BUSD) use for reclassification? (6:15:17)
 - Response Erika P.,: [One of the criteria] would be scoring a 4 on the Summative ELPAC (6:15:52)
 - Response Adriana M.,: [Another Criteria] parents (parent opinions) (6:16:14)
 - Response Ozge H.,: Parent consultations (6:16:38)
 - Response Chris A.,: we have teacher evaluations, formative assessment, basic skills test which take place 3 times a year (DIBELS, STAR and SBA (6:16:40)
- Question Ariana M.,: Do [the students] have to pass the three tests that they're given in one year (6:17:58)
 - Response Kathleen M.,: When the grades come out we look at the current grade, the latest test they took (STAR, DIBLE,etc.) and the most recent ELPAC score. They do not need to pass it 3 times in one year (6:18:25)

6:19 Reclassification to Fluent Proficient (RFEP)

- We celebrate the success of our students at the end of the year English Fluency & Multilingualism Celebration! This year it will be on May 8th, 2024
- Does anyone have any questions, concerns or comments regarding the reclassification criteria and process?
 - Question Ariana M.,: Is the celebration district-wide? (6:21:20)
 - Response Chris A.,: This celebration is for the entire district TK-12, [however] at Willard we had our own school specific celebration but I do not know how widespread that practice is (6:21:38)
 - Response Kathleen M.,: All school sites do recognize students who have been reclassified in some form... (6:22:00)
 - Response to previous Question Ariana M.,: At her elementary I haven't heard of any reclassification ... the school says it is too early for students to get reclassified but I tell them that they can get reclassified at any school level. If my student passes the test and has the grades, do I have to tell the teacher that are ready for reclassification? (6:22:25)



- Response Chris A.,: my understanding is that there would be communication coming from you directly for your school site (6:23:17)
- Response Kathleen M.,: It could be possible that only 2 of the criteria were met and that is why you have not been notified. But as soon as your student reaches all 4 criteria the school ELD teacher should be reaching out (6:22:25)

6:26 Designated ELD Curriculum

- BUSDs main curriculum for Designated ELD is called, Systematic ELD
- Students are grouped during part of the day for explicit language instruction at their proficiency level.
- Each unit has a theme. Vocabulary, language forms, and grammar are taught within a scope of sequence.
 - Question Chris A.,: Miss Marte, can you explain a little about what is the setting and how that works.(6:28:09)
 - Response Kathleen M.,: Each site may have slight variance, but generally students are pulled into groups by proficiency levels, and by grade or maybe 2 grade levels. Then in secondary (6th-12th) its actually by class entirely dedicated to ELD in their courses. (6:28:22)
 - Response Chris A.,: So secondary students are in one class but the younger students are pulled out to a separate setting, do you know when they are pulled? Is it out of the science minutes, the history minutes, what part of the day it is? (6:28:59)
 - Response Kathleen M.,: They should not be pulled from core subjects (6:**30:29**)
 - Response Erica P.,: Usually they pull my kindergartener during choice time (6:29:55)
