BACKGROUND INFORMATION

The BUSD Board of Education is keenly aware of and concerned with the level of self-reported alcohol and drug use at Berkeley High School. According to the state survey, which BHS has participated in annually, our high school students are 50% more likely than state and national high school students to engage in alcohol and drug consumption, and there is a higher rate of self-reported behavior of students attending school while under the influence of alcohol and/or drugs. The Board has discussed this, and directed our Superintendent and staff to give this issue priority.

Walgreens, an all-purpose "pharmacy" in downtown Berkeley, within 1000 feet of our Berkeley High campus, is in the process of applying for a wine/beer license/permit for off-site sale. Several years ago Long's Drugs (now CVS), also within 1000 feet of BHS, similarly began the process of obtaining a wine/beer license for off-site sale. The Berkeley School Board at that time took a position of concern and opposition to that proposed application, and Long's Drugs subsequently dropped its application. ABC (alcoholic beverage control) has often stated that it relies on high schools and school districts recommendations if these school institutions are within 1000 feet of a proposed off-site alcohol beverage sale outlet.

Board member John Selawsky is requesting a Board statement of concern and opposition to the proposed beer/wine application at Walgreens in downtown Berkeley, based on concerns of abuse of alcohol and drugs at our high school, excessive underage drinking in the Berkeley downtown area, and a saturation of off-site alcohol sales within the census tract in question.

Trader Joe's, a major grocery retailer, just opened a store at the corner of MLK and University, and offers a large selection of off-site sale of not only beer and wine, but spirits as well. There are ample outlets for legitimate sales of beer, wine, and other alcoholic beverages in the downtown area.

WHEREAS, the Berkeley Board of Education and BUSD has concerns about our high schoolers' and other youths' use of alcohol and other drugs; and

WHEREAS, our own self-reported surveys indicate alcohol and drug use by our Berkeley High students exceeding by a significant percentage both state and national reports; and

WHEREAS, Berkeley High School is an open campus, and as such our downtown area is utilized by our Berkeley High students before and after school, as well as during the lunch break; and

WHEREAS, downtown Berkeley already has ample outlets for off-site sale of beer, wine, and other alcoholic beverages; and

WHEREAS, Walgreens, on the northeast corner of Shattuck and Allston in downtown Berkeley is in the process of applying for a wine/beer off-site sale license, within 1000 feet of our Berkeley High School campus; and

WHEREAS, ABC (Alcoholic Beverage Control, the California regulatory agency for licensing alcoholic sales) considers School District and School Board concerns in assessing any alcohol sales application, and especially if within 1000 feet of a school facility; and

THEREFORE, BE IT RESOLVED, that the Berkeley Board of Education directs District staff to comment and send concerns to ABC during the required comment period of the proposed wine/beer sales application by Walgreens in downtown Berkeley; and

THEREFORE, FURTHER BE IT RESOLVED that the Board is on public record as opposing the proposed off-site sales of wine/beer by Walgreens in

downtown Berkeley, and that any Board member can and should so represent the Board and the District in public discussions and hearings on this matter; and

THEREFORE, FURTHER BE IT RESOLVED that the Board direct our Board President to send a letter including this resolution to our City Council and Mayor, as well as our City Manager; and

THEREFORE, FURTHER BE IT RESOLVED this 4th day of August, 2010, the Berkeley School Board does approve this resolution.

BACKGROUND INFORMATION

The Friends of King Park and Kala Art Institute have been working collaboratively with MLK Jr. Middle School Students to create a new mural on an existing retaining wall at King Park on Hopkins Street in North Berkeley. King Park is jointly-owned and maintained by the School District and the City of Berkeley. The existing unpainted concrete retaining wall varies from 2.5' to 5' tall, forming a focal point and a curving backdrop for King Park. Frequently tagged with graffiti, the community hopes to turn this eyesore into an opportunity. The neighbors applied for a grant for a "watershed and community themed" mural in 2009 and subsequently raised over \$6000 for implementation of this collaborative project with the goal of beautifying our park with an informative, engaging, publicly accessible mural. Our grant funding must be forfeited if the mural is not completed this summer, August 2010.

The initial concepts that laid the groundwork for the mural design were developed with students in Spring 2010 as a natural extension of Kala's Artists-in-Schools "Mapping Environments" program. Two day-long workshops in the classroom were held to develop the theme and artwork with artist Steven Holloway and teacher Larry Stefl.

Where does our water come from? Where does it go? The mural will depict the journey of our drinking water from its source in the Sierra, following the Mokulumne River through aqueducts and reservoirs to our taps at home in Berkeley. In giant raindrops, we see how we depend on water (including the gardeners in the edible schoolyard), we see ourselves, and we see that stormwater flows into Codornices Creek and on to the Bay. Completing the illustration of our water cycle, storm clouds carry snow and rain from the East while fog rolls in from the Bay on the west end. An effort will be made to incorporate student work and understanding of the watershed basin during classroom workshops held at King Middle School in June 2010. This colorful and engaging mural will be approximately 250 square feet, painted by a professional muralist with the help of community volunteers during scheduled work days during July and August 2010.

With support from the Berkeley Unified School District and King Middle School, subsequent mural work may involve the re-painting of this space over a three-year period with additions and changes made by student suggestions, student initiated design concepts, and student painting with the help of the Teaching Artist from Kala Art Institute. This work will follow from classroom workshops, field instruction and direct observations.

The design will be reviewed and approved by a committee of artists and administrators, as well as by the King school community and neighbors. A full report with color photos and drawings will be given to the Board under separate cover.

Background Information:

Each year the District enters into a contract with the California State Department of Education (CDE) for funding for the Child Development Services for General Child Care & Dev. Programs (CCTR). Funding is based on actual student attendance with each full day of student attendance generating revenue of \$41.37 per day. Partial day rates are pro-rated to the full day rate.

This year the CDE has currently issued a temporary contract to Child Development based on the Governor's budget but contingent upon funding approval from the legislature. This contract could be terminated if it is not a part of the approved 2010-11 California State Budget.

Based on the funding generated by the District in previous years and the proposed reductions, the current allocation is \$2,227,850 in potential revenue for the BUSD School Age Child Development Program (BEARS).

In order to enter into the contract, the Board is required to approve the attached resolution.

For satisfactory performance of the required services, the contractor shall be reimbursed in accordance with the Determination of Reimbursable Amount Section of the FT&C, at a rate not to exceed \$41.37 per child per day of full-time enrollment and a Maximum Reimbursable Amount (MRA) of \$2,277,850.00.
