4:42 2015-16 Budget Update: We have received new funds for this year: \$7,000 in Program Improvement Funds to be used for Teacher Hourly (175 hours), and \$5,563 in EIA-SCE carryover. Principal Corn presented the following proposal on use of these funds.

- \$1,145 to pay for 5 teachers to attend March 11 conference: Adapting Reading and Writing Workshops to Support English Learners, Grades K-5
- \$1,550 for additional sub days (\$155/day) for conference attendance, teacher collaboration, etc.
- \$1,650 for series of 8 parent workshops on various topics, to pay for food, childcare, and teacher hourly
- \$7,469 for instructional materials and supplies (\$1,869 for renewal of Reading A-Z and RAZKids licenses, \$2,400 for bilingual classes, and \$3,200 for English-only classes, plus \$749 TBD)

Unanimously gave the proposal a preliminary approval, pending final approval.
