## ❖ 2<sup>nd</sup> Interim Budget Priorities review

Pauline reviewed the budget with committee: went through line items took as much out and left enough for cost such as graduation. Reviewed variance report pg 19-23 of 2<sup>nd</sup> interim book. Compared to 1<sup>st</sup> interim 89.4 2<sup>nd</sup> interim 89.3 from state income down due to mandated cost. Looked at programs if unspent, reduced their budget. Unfilled positions reduced that budget. Health cost estimates at high range, took saving there. Unencumbered saving for unspent amount 1mil. **Special Ed** increase in NPA 247k due to assessment kits. Took savings from **BSEP** program support, **LCAP** reserve. 5.5mil undesignated, it was 5.2 at first interim. 2mil maintained on BSEP services. Gap funding; LCF Funding
