REALM Charter School Winding Up Operations

On June 12, 2019, the Berkeley Unified School District (BUSD) Board of Education voted to revoke the charter of REALM Charter School, effective June 30, 2019. REALM will cease operations as a charter school and will not open for the 2019-2020 school year.

The REALM Charter School nonprofit public benefit corporation will remain active to wind down the Charter School’s affairs under the Education Code, applicable regulations, and the Closure Procedure contained in the REALM Charter. REALM remains responsible for resolving outstanding matters between REALM and students, parents, employees, vendors, and contractors.

Employees requiring verification of dates of employment for prospective employers or financial institutions, or for a copy of their personnel files, should contact REALM. Vendors/Contractors: If you entered into a contract or agreement to do business with REALM, REALM is the sole party responsible for payment. BUSD is not a party to that contract or agreement, and has no payment obligations. Please contact REALM regarding payment.
