

NOTICE TO BIDDERS

1. Notice is hereby given that the governing board ("Board") of the Berkeley Unified School District ("District") will receive sealed bids for the following project, Bid No., ("Project" or "Contract"):

**JOHN MUIR ELEMENTARY SCHOOL FOOD SERVICE UPGRADE Project
#128.2001**

2. The Project consists of but not limited to the following:

Renovation of the existing kitchen. Extend current servery boundary by demolition of current wall separating kitchen and cafeteria. Upgrade of kitchen appliances/equipment. Addition of staff restroom and changing room.

Replacement of sanitary sewer line.

New kitchen exhaust fan to serve Type 1 hood. New water heater. Provision of grease interceptor outside of building in the sidewalk with a new grease waste line from the kitchen to the interceptor. New sprinkler head layout as required by new work.

New emergency and egress lighting as required in the kitchen and supporting spaces. Replacement of interior receptacles and clock/speaker system.

Fire alarm system to be upgraded with horn/strobe to meet current code.

3. To bid on this Project, the Bidder is required to possess one or more of the following State of California contractors' license(s):

B

The Bidder's license(s) must remain active and in good standing throughout the term of the Contract.

4. To bid on this Project, the Bidder is required to be registered as a public works contractor with the Department of Industrial Relations pursuant to the Labor Code. The Bidder's registration must remain active throughout the term of the Contract.
5. Contract Documents will be available on or after February 13, 2020, for review at the District Facilities Office. In addition, Contract Documents are available for bidders' review at the following builders' exchanges:
 - A. Builder's Exchange of Alameda, Santa Clara, Solano-Napa, and Sacramento Counties.

6. Contract Documents are also available for purchase at the District Facilities Office 2020 Bonar Street, Berkeley, CA or from ARC Planwell Northern California Planroom Plans are non-refundable.
7. **Sealed Bids will be received until 2:00 PM, March 4, 2020, at the District Purchasing Office, 2020 Bonar Street, 2nd Floor, Berkeley, CA, 94702,** at or after which time the bids will be opened and publicly read aloud. Any bid that is submitted after this time shall be nonresponsive and returned to the bidder. Any claim by a bidder of error in its bid must be made in compliance with section 5100 et seq. of the Public Contract Code.
8. Pursuant to Public Contract Code section 20111.6, only prequalified bidders will be eligible to submit a bid for contracts \$1 million or more using or planning to use state bond funds. Any bid submitted by a bidder who is not prequalified shall be non-responsive and returned unopened to the bidder. Moreover, any bid listing subcontractors holding C-4, C-7, C-10, C-16, C-20, C-34, C-36, C-38, C-42, C-43 or C-46 licenses, if used, who have not been prequalified, shall be deemed nonresponsive and will not be considered.
9. All bids shall be on the form provided by the District. Each bid must conform and be responsive to all pertinent Contract Documents, including, but not limited to, the Instructions to Bidders.
10. A bid bond by an admitted surety insurer on the form provided by the District, cash, or a cashier's check or a certified check, drawn to the order of the Berkeley Unified School District, in the amount of ten percent (10%) of the total bid price, shall accompany the Bid Form and Proposal, as a guarantee that the Bidder will, within seven (7) calendar days after the date of the Notice of Award, enter into a contract with the District for the performance of the services as stipulated in the bid.
11. **A MANDATORY pre-bid conference and site visit will be held on February 13, 2020 at 9:00 am, at John Muir Elementary School, 2955 Claremont Ave. Berkeley, California 94705. All participants are required to sign in at the main front entrance of the school. Failure to attend or tardiness will render bid ineligible.**
12. The successful Bidder shall be required to furnish a 100% Performance Bond and a 100% Payment Bond if it is awarded the Contract for the Work.
13. The successful Bidder may substitute securities for any monies withheld by the District to ensure performance under the Contract, in accordance with the provisions of section 22300 of the Public Contract Code.
14. The Contractor and all Subcontractors under the Contractor shall pay all workers on all Work performed pursuant to this Contract not less than the general prevailing rate of per diem wages and the general prevailing rate for holiday and overtime work as determined by the Director of the Department of Industrial Relations, State of California, for the type of work performed and the locality in which the work is to be performed within the boundaries of the District, pursuant to section 1770 et seq. of the California Labor Code. Prevailing wage rates are also available from the District or on the Internet at: <<http://www.dir.ca.gov>>.

15. This Project is subject to labor compliance monitoring and enforcement by the Department of Industrial Relations pursuant to Labor Code section 1771.4 and subject to the requirements of Title 8 of the California Code of Regulations. The Contractor and all Subcontractors under the Contractor shall furnish electronic certified payroll records directly to the Labor Commissioner weekly and within ten (10) days of any request by the District or the Labor Commissioner. The successful Bidder shall comply with all requirements of Division 2, Part 7, Chapter 1, Articles 1-5 of the Labor Code.

17. The District shall award the Contract, if it awards it at all, to the lowest responsive responsible bidder based on:
 - A. The base bid amount only.
18. The Board reserves the right to reject any and all bids and/or waive any irregularity in any bid received. If the District awards the Contract, the security of unsuccessful bidder(s) shall be returned within sixty (60) days from the time the award is made. Unless otherwise required by law, no bidder may withdraw its bid for ninety (90) days after the date of the bid opening.
