

### Middle School Enrollment Policy Community Engagement

**Process:** May 2021-November 2022



\*In his newly expanded timeline, the Superintendent will bring a recommendation to the Board in time for a Board decision by November 2022, at the latest, in order to make enrollment changes in time for the 2023-2024 School Year.

Feedback during this Fall focused on three options:

- 1. Keep the same assignment model
- 2. Create three assignment zones for middle schools, similar to the zones for elementary schools
- 3. Create feeder schools for all three middle schools

Based on our review of feedback collected in the Fall of 2021 (Phase II of our work), the following themes stood out for discussion and feedback:

- Program resources at all three middle schools What are the academic programs at all three middle schools like? And should they be adjusted in any way?
- Resources
- Transportation
- Social-emotional well-being
- Equity/access/inclusion

We envision that BUSD staff will recommend that the Board formally adopt a <u>single "finalist" model</u> in June so that the community has a clear sense of the district's direction for the 2023-24 school year.

After a possible June decision to select a single finalist model, we envision that this finalist model will be open to additional feedback and fine-tuned over the course of the following five months, from June to November, 2022.

In November, 2022 we envision that the Board could approve a final model for implementation in 2023-24.
