The district administers a scheduled maintenance program to ensure that all classrooms and facilities are well maintained and in good repair. A work order process alerts district personnel of any maintenance needed to be performed and ensures that emergencies are given the highest priority.

Safety issues are the top priority for Maintenance and Operations. District maintenance supervisors inspect school sites continually and complete repairs in a timely manner. They use a work order process to ensure an efficient, prioritized repair process.

To determine the condition of our facilities, our district sent experts from our facilities team to perform an inspection using a survey called the Facilities Inspection Tool, which is issued by the Office of Public School Construction.

Statewide Assessments

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and
- Uniformly administered across a grade, grade span, school, or district to all eligible students.

Options

Note that the CAAs could only be administered in-person following health and safety requirements. If it was not viable for the LEA to administer the CAAs in person with health and safety guidelines in place, the LEA was directed to not administer the tests. There were no other assessment options available for the CAAs. Schools administered the Smarter Balanced Summative Assessments for ELA and mathematics, other assessments that meet the SBE criteria, or a combination of both, and they could only choose one of the following:

Percentage of Students Meeting or Exceeding the State Standard on CAASPP

The main building is an interconnected, partial two-story reinforced concrete building with a partial basement. The facility strongly supports teaching and learning through its ample classroom, field, creek and playground space.

The safety of students and staff is our primary concern. Visitors and volunteers are required to check in at the main office. During lunch, recesses, and before-and-after school, staff members and the administrator supervise students and school grounds to ensure an orderly, safe environment. The school is always fully compliant with all rules, laws, and regulations concerning state earthquake standards and hazardous materials. An Earthquake, Lockdown or Fire drill is held every month for the students and staff. John Muir follows COVID-19 risk mitigation protocols developed by the District in consultation with local Public Health agencies.

Safety procedures, including elements of our Comprehensive Safe School Plan, are reviewed with school and district staff at the start of each school year. The plan was last updated in the Spring of 2022.

Professional Development

During the 2021-22 school year all new teachers to BUSD engaged in two days of professional development on curriculum and effective pedagogical practices to empower students on 8/9 and 8/10 2021. All TK-8 teachers engaged in 3 full days of professional development on 8/12, 10/11, and 1/31. Professional development focused on integration of the 7 tenets of Ethnic Studies and the Five Pursuits of abolitionist teaching. Additionally, teachers engaged in deepening their understanding on Universal Design for Learning. All 6-8th grade teachers engaged in 5 two hour sessions which were dedicated collaboration time to continue to deepen their learning. All TK-5 teachers engaged in collaboration on the writing process and scoring. Every TK-8 site has a Literacy Coach Equity Lead, and a Math Teacher Leader to support teachers in reflecting and improving math and literacy teaching skills through co-teaching and direct professional development at staff meetings. Professional development in TK-8 has explicitly focused on best practices to engage and empower students through abolitionist and culturally responsive teaching. New teachers participate in a rigorous District Teacher Induction program. Teacher-initiated professional development is supported through local funds earmarked for this purpose and through school site funds, as well.
